4. As per Sindh Public Procurement Rule 2010 (SPP Rule 2010), the Departmental Purchase Committee held a meeting on 2/12/2013 in chair of its chairman purchase Committee. The chairman purchase committee publicly announced the technical proposal and the matter was referred to technical committee for further proceeding.
5. After completion of overall technical evaluation & formalities as per SPP Rule 2010, the Departmental Purchase Committee had accepted our (Happy Traders) technical bid proposal and announced the financial bid proposal of us (M/s Happy Traders) as declared successful bidder as per specifications, and subsequently the Evaluation report of the same had been published at SSPRA website by the department.
6. After this, we got information that these bids have been called by the Department Grievance committee for review as one of the bidder has lodged a complaints against this. We believe this complaints had been probably lodged ~~after~~ the financial opening of this bid but despite of this unethical complaints the department Grievance committee had accepted the groundless complaints of the one of the bidder.
7. Upon getting this information, it is to inform you that our firm has also approached to you kind honor that we should also be given a chance to explain our point of views before taking any decision vide our office letter No.HT/2013-14/CPO/ dated 21st Feb-2014. But unfortunately the Department Grievance Committee deliberately did not provide us any chance to explain our point of views before taking any decision. This is certainly not justified.
