Technical committee meeting for TENDER NO ICCBS/HEJ/PRF-12322/SSY17-260917-2<sup>ND</sup>-Time, was held on October 19<sup>th</sup> 2017.

Following recommendations were made:

03 Security companies participated in the bidding process. The bid of Famous Security Company (pvt) Ltd. was rejected as it was not fulfilling the requirements of the advertisement for nationwide capabilities to provide security to the assets of ICCBS which are also outside of Sindh Province. The Famous security Company (pvt) is only providing services in the Sindh province and is not authorized to provide services outside Sindh. The committee recommended awarding the tender to Indus Security Services (Pvt) Ltd at Rs 13147200 (inclusive of all taxes) which has offered lowest prices among all technical qualified bids.




