- The methods for bidding documents observed as single stage-one envelope procedure.
- iii. The tenders were opened on 20.11.2017 before the tender opening committee.

The Committee was informed that 38 bidders have purchased the 114 Bidding Documents upto dated: 20.11.2017 and 114 Nos. have responded the bids and received today upto 2:00 PM in the office of the Executive Engineer Provincial Buildings Division Hyderabad and the same were opened before the Procurement Committee at 2:30 PM in the presence of representatives of participants.
