Item #7: Approval for Decoration & Catering Services for Convocation-2017

Discussion: Sr. Purchase Executive briefed the committee about the tender proceedings for Decoration & Catering Services for Convocation-2017. Tender opening date for Technical evaluation was November 15, 2017 at 11:30am, which was followed by the TEC meeting. The PC reviewed the TEC-Minutes, weighted aggregated sheet and individual technical evaluation sheet. In response of this tender, four bidders participated: qualifying percentage is 70% out of which one bidder fulfilled the technical criteria, hence their financial bid was opened. The committee reviewed the comparative statement and TEC minutes. Under Rule 48, the committee observed that the bid price is competitive with the previously (last month by M/s Larosh Caterers) submitted bid that stood at Rs. 5.6 million for the same services.

Decision: The committee approved to avail the services of Decoration & Catering Services for Convocation-2017 to M/s Manzoor Sons at the total cost of Rs.2,648,245/- (including SST) being the technically qualified and responsive evaluated bidder, subject to the availability of budget.

Action: Sr. Manager Purchase & Stores will implement the decision in accordance with the prescribed rules & regulations framed by IBA PP&P and SPPRA.
