The chairman informed committee that, though, the Tender was called on 29-12-2010, but due to pre-occupation of superintendent District Jail Mirpurkhas the Tenders are opened on 6-01-2011

The committee received four sealed Tenders from contractors and opened them. The rates offered by the Contractors are shown below against each.

It was observed that there was tie-up at the lowest rates viz. Rs. 95 per prisoner per day, the contactors preferred to remain absent during opening of the tender / documents.


The committee considered both the lowest bidders, and decided that, the new contractor Mr. Muhammad Saleem may be given chance for betterment of service but if he fails to respond within stipulated time, then the contract may be awarded to next successful Bidder, i.e. Mst: Janat.

Accordingly, contract for supply of cooked food to the prisoners confined in Judicial Lockup Umerkot is awarded to Mr. Muhammad Saleem at the rate of Rs. 95/= per prisoner per day, subject to conditions laid down from time to time. However in case of his failure to respond within stipulated time the contract stands awarded to Mst: Janat.


