





Meeting started with the recitation from Holy Quran. The Committee was informed that sealed bids were invited through press for hiring of Security Services was published in leading newspapers; Daily Jang (Urdu) as on 27.09.2017, Daily Kawish (Sindhi) as on 29.09.2017 and Daily Dawn (English) on 27.09.2017. The same was also hosted/put on the website of BIE Karachi and SPPRA at Sr. **No.34633** dated **03.10.2017**. According to SPPRA Rules, Single stage - two envelopes bids, containing Technical and Financial Proposals, were invited for the purpose.

In response to advertisement, Five (5) interested firms purchased the tender documents, out of which, following Three (3) firms submitted their bids; containing technical & financial proposals along-with their company's profiles:

- 1) M/s. Crown Security Services (Pvt) Ltd .
- 2) M/s. Omer Razzaq Enterprises (Pvt) ltd.
- 3) M/s. Muhafiz Security (Pvt) Ltd.

The Technical proposals were opened by the Committee on 19.10.2017, in presence of the representatives of Bidding Firms. After opening the technical proposals, the Committee carried-out the technical evaluation of the company profiles as well documents provided by the bidding firms in support of their technical proposals. *As per evaluation criteria, 75% marks were required to be obtained by a bidding firm to qualify for further competing in bidding process.*

Accordingly, a Bidder Qualification Report was prepared, according to marks assigned to each para-meter given in evaluation criteria (attached at Annexure-A). As per para-meters given in evaluation criteria, the position of marks obtained by firms, are given as follows:

- M/s. Crown Security Services (Pvt) Ltd. 95%
- M/s. Omer Razzaq Enterprises (Pvt) Ltd. 100%
- M/s. Muhafiz Security (Pvt) Ltd. 90%

In view of the position of marks obtained by the bidding firms, the Technical Proposals in respect of all the three contesting firms were found qualified/responsive and accepted by the Committee and the Committee recommended opening their Financial Proposals on the specified date.

During the opening of Financial proposal, Mr. Muhammad Jaffer, Member, Procurement Committee has informed that in last year same exercise were made and work order has been issued to M/s. Famous Security Services, being a lowest, for the period of three (03) months further period be increased subject to performance but unfortunately the service of security company was very poor although the security persons have been hired from surrounding area and they were untrained and posted in the premises of BIE, Karachi. On the basis of performance of Security Company and subsequently approval accorded by the Competent Authority, Contract of the Security Guards was cancelled.

Keeping in view of the above position, it is proposed that the contract shall be awarded to the lowest bidder being the Responsive Bidder, and the services of their security guards shall be monitored by the committee headed by the Deputy Secretary (Administration General) and payment shall be made on the basis of certification made by the committee in every month. The following members of committee are suggested:

- Syed Hadi Hassan, Dy. Secretary (Administration General) Convener
- Mr. Mirza Adnan Baig, Superintendent, Audit Section Member
- Mr. Shamimullah Siddiqui, Maintenance Supervisor Member

Procurement Committee has recommended to award the contract for Hiring Security Guard to **M/s. Muhafiz Security Service (Pvt) Ltd** with a worth of **Rs.6,300,000/-** on the basis of lowest quoted rates and being the Responsive Bidder, as follows:
