These items can however, be procured separately through quotations as provided under Rule-16 of the SPPRA Rules-2010 since the department have the right to purchase any of the items mentioned in the N.I.T in terms of the condition # 4 of the terms & conditions specified in Tender Quotation. Owing to the urgency involved in the procurement, therefore, Departmental Purchase Committee recommends to award the contract to M/s Rajput Enterprises, after fulfilling the codal formalities.


