I am directed to refer to your letter No:BBU/PD/EE/2017/373 dated 16.10.2017 and to observed that;

- Published copies of NIT do not confirm the compliance of Rule-17(2) of SPP Rule, 2010 (amended 2017) according to which NIT require to be published in leading and widely circulated newspapers.
- Justification regarding using of relevant bidding documents of 'Goods' instead of 'Works' cannot be considered as plausible because;
  - a) Procuring Agency neither any supporting documents is attached for evidence nor minutes of bid opening meeting confirm the compliance because the term 'Scheduled' and 'Non-schedule' items (which related to procurement of works) envisaged.
  - b) NIT envisaged the 'Single Stage One Envelope' procedure for procurement of 'Civil Works' whereas Bid Evaluation Report shows that bids of civil works were evaluated on 'Single Stage Two Envelope' procedure.
  - c) Evaluation criteria in terms of Rule-21(A) of SPP Rule, 2010 (amended 2017) is not mentioned in the bidding documents.

2. I am also directed refer to the Bid Evaluation Report(s) of the subject NIT received vide your letter dated 14.11.2017. It has been observed that;

- i) Reasons of disqualification of M/S S.A Enterprises and N.A Enterprises are not as per Rule-46(2)(e) according to which Procuring Agency (PA) shall evaluate the Technical Proposal in a manner prescribed in advance, without reference to the price and reject any proposal which does not conform to the specified requirement. Clarification is required.
- ii) Rate(s) quoted by 1<sup>st</sup> lowest bidder(s) against most of item(s) exceeding the limit of estimated cost mentioned in the NIT & Annual Procurement Plan. Justification regarding excessive amount is required.

- iii) Remarks column of item No:9 envisaged the recommendation for award of contract to the 2<sup>nd</sup> lowest bidder whereas comparative statement shows the recommendation for award of contract to the 1<sup>st</sup> lowest bidder. Clarification is required.

3. In view of above, it is advised to take an appropriate action under relevant rule to comply the procurement procedure, rules, regulation in letter and spirit.

4. It may be noted that it is the sole responsibility of procuring agency to carry all the public procurement by observing SPP Rules, 2010(Amended 2013), regulations and procedure in vogue. Non-compliance of Sindh Public Procurement Rules, 2010 (amended 2013) shall render the case of procurement as 'Mis-Procurement'.

2. In NIT relevant bidding documents were used for relevant works e.g Goods & Civil as per SPPRA rules.
3. Minutes of bid opening meeting for NIT were already sent to your good office along with letter No.BBSU/PD/EE/2017/ 377 dated 14.11.2017(Copies attached herewith)
4. It is to ensure your good office that we as procuring agency are bound to full fill and obey SPPRA rules, We have carried out single stage one Envelop for civil works as per SPPRA rule, were as in bid Evaluation Report single stage two envelop is clerical error.
5. M/s S.A Enterprises & N.A Enterprises technical proposals were reject in procurmnt committee during the process of Bid Evaluation Report of said NIT.
6. In NIT lowest bidder had exceded the limit of estimate cost, which is very unfortunate but these rate were quoted by the contractors PA has nothing to do with it hence Benazir bhutto Shaheed University has decided to revise estimated cost and is in process.
