A meeting of the Procurement Committee STEVTA was held on 20-11-2017 at 12:00 P.M. in the committee room of Sindh Technical Education & Vocational Training Authority, ST-19, Block-6, Gulshan-e-Iqbal, Karachi, to open the Bids (Technical & Financial Proposals) invited for procurement of Tool Kits in 06 trades for 35 institutions under Prime Minister Youth Skill Development Program (PMYSDP) Phase-II Dropouts and Phase-III Batch-I&II for Sindh TEVTA Institutions.

02/- The Committee was informed that the tender notice was published in the leading newspapers; viz: Daily DAWN (English), JUNG (Urdu) and KAWISH (Sindhi) on 03-11-2017. The same was also hoisted on website of SSPRA at Sr. NO. 13-18 of 35092 on dated 03-11-2017 according to Rule-46(1) of SPPRA Rules-2010, the Single Stage-One Envelope bids, containing Technical and Financial Proposals, were invited to procure the Tool Kits.

03/- The Bid document comprises the Technical & Financial Proposal containing specification of Articles for Dress Making, General Electrician, Refrigeration & Air Condition, Beautician, Plumbing and Welder Trades.

04/- In response to advertisement; Ten (10) interested firms purchased the bidding documents, out of which Six (06) firms submitted their bids; containing Technical & Financial proposals supported with company profiles, wherein, one (01) firm M/s. S.S. Marketing & Advertising was rejected due to non-submission of Bid Security in the form of P.O/D.D. 2.5%.

05/- The Bids were opened in presence of the bidders or their representatives and evaluated with regard to the qualifications requirements mentioned in the bidding document. (A), the Bids Evaluation Statement of Technical Qualifications was prepared and attached with the Minutes of meeting. (**Annexure-'A'**)

06/- On opening of Technical & Financial Proposals, Committee has observed that following firms submitted their bids for supply of Tool Kits for Dress Making, General Electrician, Refrigeration & Air Condition, Beautician, Plumbing and Welder Trades.

- 2) *M/s. Sindh Traders Khairpur.*
- 3) *M/s. Aamir Traders, Karachi.*

07/- On preliminary Technical Evaluation of the documents enclosed with the bidding documents, the committee has observed that M/s. Manzoor Ali Qadri & Co. Karachi, submitted their Bid Security amounting to Rs.159,375/- in shape of Pay Order No. 14019750 dated 17.11.2017 for 03 Trades viz; Dress Making (Sewing Machine), General Electrician and Beautician.

08/- M/s. Sindh Traders Khairpur has submitted their Bid Security amounting to Rs.250,000/- in shape of Pay Order No. 00388158 dated 18.11.2017 for all 06 Trades as mentioned in the Bid documents.

09/- M/s. Aamir Traders Karachi has submitted their Bid Security separately for each Trades and accumulated amounting to Rs.159,375/- in shape of Pay Orders No. 01546924 to 01546929 dated 20.11.2017 for all 06 Trades as mentioned in the Bid documents.

10/- M/s A.J. Enterprises Karachi has submitted their Bid Security amounting to Rs.150,000/- in shape of Pay Order No. 02264209 dated 18.11.2017 for all 06 Trades as mentioned in the Bid documents.

11/- M/s Shan & Brothers Nawabshah has submitted their Bid Security amounting to Rs.60,415/- in shape of Pay Order No. 08101154 dated 18.11.2017 for Single Trade namely; General Electrician as mentioned in the Bid documents. On Evaluation of Bid document, it has been observed that the Firm has not submitted its profile and other relevant documents. Therefore, the Procurement Committed has decided to disqualify the Firm M/s Shan & Bothers Nawabshah on account of non-responsive for further process in the competition.

12/- After evaluation of Technical & Financial proposals, the following 04(four) Firms were found technically qualified in conformity to the standard/criteria mentioned in bidding document. Keeping in view the Technical Qualifications requirements, the Committee found the technical proposals of following firms "Responsive" to compete in bidding process. Accordingly the committee prepared comparative statement (both of Technical Specification & Financial) (Copy at Flag-C) and recommended to award the contract to the lowest bidder whose bid was substantially responsive.






