


Decision:



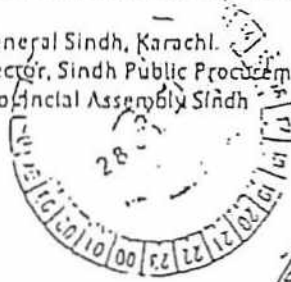


