With the approval of Administrative Department, the Director (Admn/MVR), Excise, Taxation & Narcotics Control Karachi has constituted a technical sub-committee for the evaluation of technical proposals of Tax Token Stickers for 2/3 wheelers and 4 wheelers with certain TORs as mentioned in the order vide No.DVR/MR(43)/Number Plates/2017-18/3173 dated 31st October, 2017 (Annexure-A). Accordingly a meeting of Technical Sub-Committee was held on 03-11-2017 at 03:30 pm in the office of the Deputy Director (H.Q)/Chairman Technical Sub-Committee, Directorate General Excise, Taxation & Narcotics Control Sindh Karachi.(Annexure-B)

The participants were:

1. Mr. Waheed Shaikh Deputy Director (Admn) M R Wing Karachi / Member

2. Mr. Aamir Hussain Examiner of Stores, Industries & Commerce Department / Member.

The envelopes containing the bidding documents submitted by M/s Pakistan Trading House and M/s Fine Solutions along with the sample of stickers were opened and perused in detail for evaluation purpose (Attendance Sheet enclosed at Annexure-C).

Following the parameters of the evaluation criteria for bidders described in the tender document, the bidding document were scrutinized in detail by all the members of the Technical Sub-Committee and every member individually awarded the marks, a consolidated statement of the marks obtained by each bidder is enumerated as (Annexure-D & E).

As discussed in the meeting of the Technical Sub-Committee. The chairman Mr. Riaz Hassan Khoso Deputy Director (H.Q) along with Mr. Aamir Hussain Examiner of Stores/Member visited the premises of **M/s Pakistan Trading House** and **M/s Fine Solution** on 20th November, 2017 at the address mentioned in the company profile.

M/s Pakistan Trading House:

The team visited the manufacturing factory situated at Flat No.9, 02nd Floor, Allah Bukht Afandi Manzil Opposite Bottle Gali Shahrah e Liaquat, Karachi and saw the process of printing for tax token stickers. The bidder has provided the documents of rental agreement regarding manufacturing unit. The team also observed the making of required material. M/s Pakistan Trading House as declared in the documents had three office premises, one of which had manufacturing facility, the company also provided valid rental documents of all the premises as proof.

M/s Fine Solution:

The team visited the manufacturing unit of M/s. Fine Solution situated at B-93, Mehran Town, Korangi Industrial Area, Karachi. The bidder did not provide any documents relating to manufacturing unit at the time of bid submission. They avoid to

produce any document during the course of visit and showed inability to print the required material i.e. tax token sticker in presence of the team. M/s Fine Solution has declared three offices in which one tenancy agreement has expired. The Bank / financial statement submitted for two years and three months instead of required four year statement to evaluate average turnover of last four years.

Moreover, regarding the mandatory requirement both the bidders have furnished NTN Certificate, Sales tax registration, Professional tax proof issued by the concerned authorities. Both the bidders have produced ISO certificates.

Further samples of Tax Token Stickers provided by M/s Pakistan Trading House are as per specifications of bidding document but samples provided by M/s Fine Solution are not as per specification as provided in bidding documents as they are not adhesive to test the quality.

Recommendation.

The technical committee vide meeting dated 24th November, 2017 scrutinized all the documents produced by the participating firms as provided in bidding documents for technical qualification. M/s. Pakistan Trading House obtained 95 marks whereas, M/s. Fine Solutions got 35 marks. Hence, M/s. Pakistan Trading House is qualified for further participation.


