


Decision:



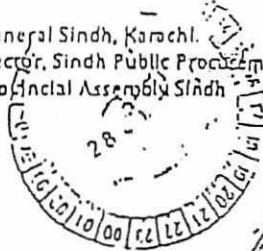
