Whereas technical documents of other 06 companies were alright except minor clarifications. However, some representatives of the companys' agreed that overall their technical bids are satisfactory and proposed that in order to save the time, financial bids may also be opened today and technical proposal of 03 lowest bid offering companies' may be evaluated as per satisfaction of procurement agency for the final selection and award of the contract. All 06 participating bidders from serial NO.01 to 06 agreed and signed the proposal (the copy of the consent duly signed by the participating companies is attached as Annexure "C")

After such consensus, all the committee members accepted the proposal to open the financial proposal of the 06 participating companies. The financial proposals of the 06 companies were found according to the specification. The rates quoted were announced loudly before all representatives of 06 companies. It was also resolved that the next meeting for the further minor evaluation of technical aspect the 03 lowest financial bidding companies will be held on 23-02-2016 and will be brought in the notice of the lowest evaluated cost offering bidding company for compliance before award of contract.
