"That this division is purely based on repair and maintenance work of the water trunk mains and due to routine repairing works the particular amount of turnover does not matter for the Procurement Agency while the condition of 80% turnover mentioned in the N.I.T is just the examination of bidder that the company's A/c is operative or dormant / ceased and also fulfilled the requirement of the Tender procedure in accordance of Rule-46(1)(ii) of SPPRA-2010 as well as the those contractors who are participating in the bidding process are well aware about the turnover of 80% at least last three year because the estimated cost clearly mentioned in the N.I.T's Sr. No.12 for guideline of the Contractors".

However, please condone violation if happened from your point of view and after justification of the subjected matter, kindly take appropriate action in this regard and do the needful as deemed fit please.

Your observations / advice and co-operation in this regard, are our satisfaction, we are looking forward for more transparency in the tender / evaluation process.
