

3. The tender in sealed cover superscribed with the name of work should be dropped in the tender box kept in the committee room of the office of Commissioner, Karachi.

4. In case the date of opening is declared as a public holiday by the Government or non-working day due to force majeure the next official working day shall be deemed to be the date for issuance or submission and opening of tender. The time & venue will remain same.

5. The tender documents will be issued to the firms on submission of application in their original letterhead along with Pay Order of Tender Cost in favour of Commissioner Karachi as mentioned above.
