

THIS AGREEMENT is made on at day of August, 2017 between School Education & Literacy Department, Government of Sindh (hereinafter called "The Procuring Agency") of the one part and M/s Cyber Internet Services (Pvt.) Ltd. (hereinafter called "The Supplier") of the other part:

WHEREAS the Procuring agency invited bids for installation of 20 MB/sec internet connectivity at IT Data Center and has accepted a bid by the Supplier for supply of those services not exceeding Rs. 164,313/- (Rupees One Hundred Sixty Four Thousand Three Hundred Thirteen only) per month for a period of six (6) months (hereinefter called "the Contract Price").

The Procuring agency hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the times and in the manner prescribed by the contract.
