02. While going through the bid documents, it was observed that there were certain discrepancies in the bid documents of lowest bidder i.e. M/S S.R Enterprises. He has quoted figures as mentioned below:-

03. From the above figures, the Committee is unable to draw any conclusion that what is the relationship of above mentioned three figures, as the Rebate amount quoted as Rs.2,622,695/- is 13% of the total amount of Rs.20,174,584/-. Also the difference of total amount of Rs.20,174,584/- and Rebate amount of Rs.26,622,695/- does not come to Rs.13,147,560/- which is final rate quoted by M/S S.R Enterprises in the bid documents.

04. It was also observed that M/S S.R Enterprises made same type of discrepancies in the bid documents of another tender for Repair/Renovation for remaining work of Office Block & DSP Hostel at PTC Shahdadpur & overwriting in quoted rates without any initial/signature.

O5. Therefore, committee decided that letter to explain above discrepancies may be issued to M/S S.R Enterprises & directed Secretary of Procurement Committee to issue the same immediately.

02. While going through the explanation of M/S S.R Enterprises dated 25-12-2017, it was observed that the explanation submitted by M/S S.R Enterprises is not satisfactory and the explanation does not clarify the discrepancies/confusion/ambiguity. In the explanation letter M/S S.R Enterprises was also asked to explain as of how the same kind of discrepancy occurred into two separate tenders, but the said query has not been addressed in the reply submitted. Further the total amount quoted by M/S S.R Enterprises which was also announced at bids opening is more than 30% below (35% below) then the quoted rates & liable for rejection vide Notification No.DD(A&F)/SPPRA 17-18/22 dated 05-07-2017.

- 03. Keeping in view the above discrepancies and unsatisfactory/incomplete reply of M/S S.R Enterprises the Committee unanimously decided to reject the bid of M/S S.R Enterprises.
- 04. However, after detail scrutiny of bid documents of M/S Ghulam Asghar Chachar 2nd lowest it transpired that company has not provided 03 work orders, affidavit & bank statement & does not fulfill the requirements of the tender, therefore stands disqualified.
- 05. The Committee decided to accept the Bid of M/S Bahadur Ali Shaikh amounting to Rs.15,025,506/- being 3rd lowest and fulfilling all the requirement of bidding documents.
