- 2. The project comprises of three package (A, B and C) with a combination of procurement process under the PPP and Traditional modes. Therefore, the pre qualification applications were invited from the prospective contractors to qualify the both bidding procurement procedures. This bidding process relates to the pre qualification of the contractors in Traditional mode. The notification of the PC is attached as Annexure -B
- 3. The pre qualification applications from prospective contractors for the project were invited in accordance with rule 27 of the Sindh Public Procurement Rules, 2010 (the SPPR Rules) for which the Request for Pre Qualification (RFQ) was issued on 25th February 2017 under SPPRA ID 31806 with submission deadline of 28th April 2017. In response to the RFQ document for the Project, issued by Transport & Mass Transit Department, the bidders submitted their prequalification applications with packages A, B and C. as detailed below:

- 4. Transaction Advisors / consultants (BLIC GmbH, Germany, EA Consulting Pvt. Ltd., DCC Pvt. Ltd., KPMG, Ahmed & Qazi) (the "Consultants") presented the evaluation report on the Pre qualification documents to PC members. The applications have been evaluated and scored based on the evaluation criteria as stipulated in the RFQ. Bidders were required to score a minimum combined score of 70 to qualify this round.
- 5. As per evaluation of the Consultants, the following companies / consortium have qualified as per the RFQ criteria. Presentation of the Advisory Consortium on the Technical Evaluation is attached as Annexure B. Members of the PC collectively affirm and approve the firms recommended for pre qualification as detailed below and Request for Proposal (RFP)documents and procedure of competitive bidding of Single Stage two envelope process.





#### 1.1. Objective of the PQ

One of the most important component of BRTS project is the "Integrated Intelligence Transport System (IITS)" which aims to create an integrated system environment that supports seamless communications of system and sub system, characterized by user friendliness and customer focus. According to the scope the following transport related systems are considered in the IITS components.

System 1: Automated Fare Collection (AFC) system

System 2: Fleet Management / Fleet Management System (AVL)

System 3: Passenger Information system (RTPI)

System4: Business Intelligence Software System5: Bus Depot Management System System6: Operation Control Centre (OCC) System7: Communication Network System System8: Security & Surveillance System

System9: Energy Management System System10: Bus Docking System

For the purpose of procurement installation, commissioning, calibration under the IITS strategy, the project scope has been divided into three packages. The PQ process for prospective contractors for each package is mentioned in subsequent section.

The main objective of the PQ was to shortlist thereputed companies/firms/JVs to Design,Procure, Finance, Operate, Maintain and Transfer IITSfor Bus RapidTransit System (BRT) – Green Line (21 Stations Mandatory) and Orange line.

Further, using the PQ responses, a final setup of the system concept for the RFP can be designed to ensure that the packages are competitive and attractive for companies.

#### 1.2. PQ Dates

- The PQ was floated on25<sup>th</sup>February 2017 by the Government of Sindh under codes 31807 and 31806.
- The Submission deadline was of 28<sup>th</sup>April 2017.
- · Clarifications from the bidders have been requested in first week of July 2017
- Final Set Documents from bidders after clarification request have been provided to the JV on 30<sup>th</sup> August 2017.

#### 1.3. Important Note

The PQ evaluation was using submitted documents only. There was a request for information to allow bidders to comply with the PQ procedure for missing documents.

Contrary to the RFP evaluation procedure, the bidders' response is not yet evaluated by contacting third parties for confirmation of provided information.




Figure 1: IITS recommended Packages
