- 9. Sand from only approved quarry shall be used in all items involving use of cement. Pit sand shall not be allowed to use.
- 10. Sweet and potable water only shall have to be used in construction work which is to be arranged by the contractor.
- 11. The bid money 2.5% of the bid value submitted by you will be treated as "Performance Security" remaining 5% amount will be deducted from each running bill as security deposit.

CONTRACT AGREEMENT

This contract agreement (hereinafter called the "Agreement") made on the day of -2018 between Addl:IGP/Khi, Range (hereinafter called the "Procuring Agency") of the part and M/s Emizen Engineering & Co (hereinafter called the "Contractor") of the other part.

Whereas the Procuring Agency is desirous that certain works, viz Repair / Renovation work of Camp Office Banglow 87/1 of Addl:IGP/Khi at Clifton Karachi, amount of Rs. 3.975 Million should be executed by the Contractor and has accepted a Bid by the Contractor for the execution and completion of such works and the remedying of any defects therein.

Now this Agreement witnesseth as follows:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the conditions of Contract hereinafter referred to.
- The following documents after incorporating addenda, if any except those parts relating to instructions to bidders, shall be deemed to form and be read and constructed as part of this Agreement Viz:
 - a) The Letter of Acceptance.
 - b) The completed form of Bid along with Schedules to Bid
 - c) Conditions of Contract & Contract Data.
 - d) The priced Schedule of Prices/Bill of quantities (BOQ)
 - e) The Specifications and
 - f) The drawings.
- 3. In consideration of the payments to be made by the Procuring Agency to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Procuring Agency to execute and complete the works and remedy defects therein in-conformity and in all respects within the provisions of the contract.
- 4. NOW THEREFORE, the party on first half agree to award the contract of the above work, as per terms & conditions and according to Government of Sindh, Sindh, Public Procurement Regularity Authority (SPPRA) standard rules & regulations which have already been provided with tender documents and are again supplied along with this agreement, to the party of second half.
- The party of second half has agreed to carry out the work at above locations as per Scope of Work provided by party of first half, and shall complete the work at all locations within period of 90 days from the date of this agreement.
- 6. The party of second half shall keep the party of first half fully informed of the progress of work by submitting progress report on monthly basis or when ever required by the party of first half.
- In case of any problem or hindrance in execution of work from any sub-ordinate office of Police department, the
 party of second half shall immediately report the matter to Assistant Engineer, CPO, Sindh, Karachi.
- 8. That party of first half shall be entitled to verify the work before acceptance of bill and release of payment through committee or any outside professional firm/authority.

- That party of first half shall be entitled to point out and demand rectification of any fault in the work or material used in work, which the party of second half shall remove or change without any extra cost, provided such work is covered in the scope of work of the contract.
- 10. That all communication between the parties shall be in writing, and if posted to the given addresses shall deem to have been conveyed.
- 11. That in case of any difficulty both the parties can approach and consult each other to resolve any issue in the best interest of Government work by mutual consent in writing.
- 12. That party of first half shall have right to arrange inspections and monitoring of the works covered under this contract through Work Inspection / Execution committee already constituted by the Additional IGP Karachi Range and the party of second half shall not have any objection to such visits/ inspections.
- 13. The repair/renovation work has been handed over to the second party according to the rates and following condition:
 - a) If the work is left incomplete by the second party, the First party will hold its payment at any stage.
 - b) It is declared that the above named second party is the sole proprietor of the said company and the second party has no partner.
 - c) No payment will be released without inspection committee report.
 - d) The first party will not pay any amount if any excess work will be carried out by the second party without written approval of tender opening committee as per SPPRA Rules-2010 amendment 2013.
 - e) No bill will be entertained without pre-work and post-work photographs.
 - f) The second party will receive the payment himself.
 - g) All the old doors, windows, and pipes etc, will be counted for and kept under Safe custody till auction.
 - h) That the second party is fully bound to complete the work assigned to him within specified time, failing which the second party will pay 3% penalty of tender amount to the Government (Police Department).
- 14. Engineer deputed from works and services Department shall ensure that the work is carried out as per the requirement and under SPPRA Rules-2010 amendment 2013. Furthermore, if the Engineer is not satisfied with the progress he may at any time held the work and there shall be no payment from the first half to the second against the work done.
