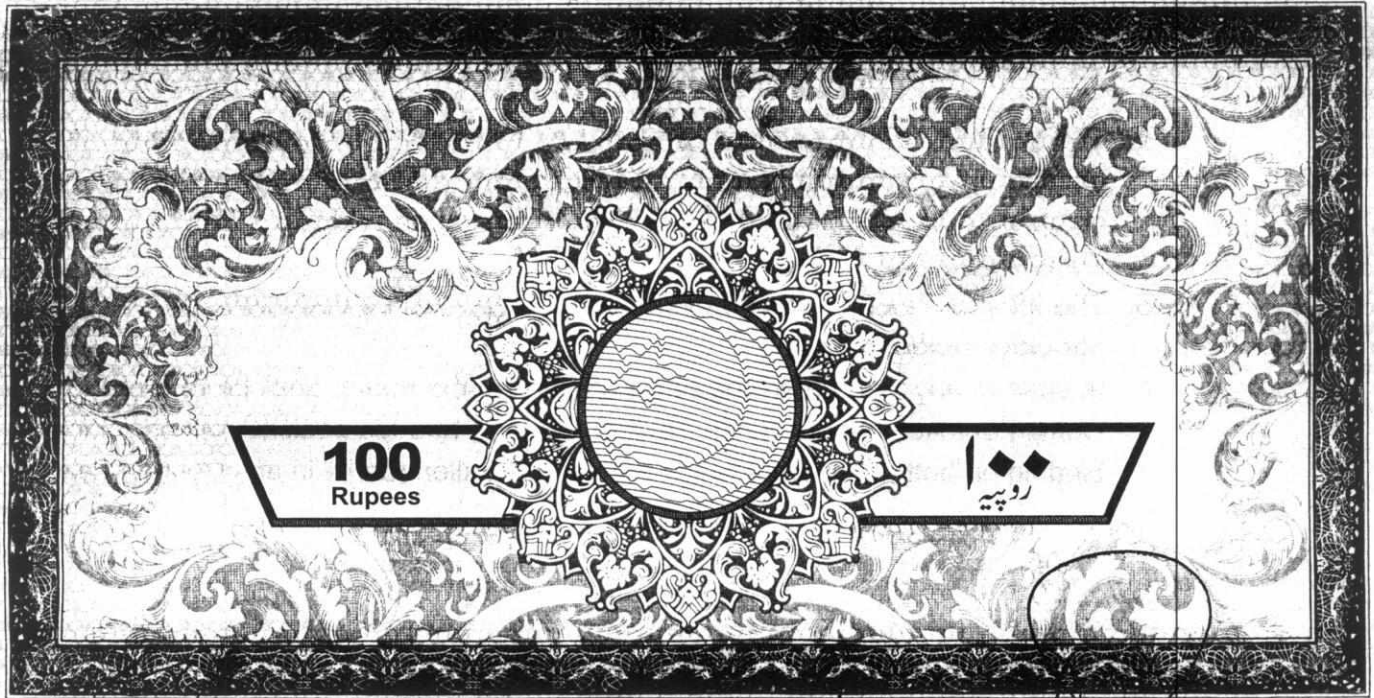

The Agreement regarding terms and conditions for providing Transport for supply of Free Distribution Textbooks to Textbooks to 99 Taluka Head Quarter of 28 District including Jamshoro to Karachi For Class X of Sindh Province on the rate quoted in the bidding documents, is made this day the 26th April, 2016, between the Sindh Textbook Board, Jamshoro the first party (hereinafter called the Board) and the party offering the rates of Transportation at first lowest viz **M/s (TCS Company Hyd)** as a second party (hereinafter called as a contractor/bidder).

**The terms and conditions are as under:**

1. The Party shall have to deposit 10% of Total amount of contract as a security in shape of Pay Order/ Demand Draft of scheduled Bank before execution of agreement. The security deposit will be released on the satisfactory completion of Job.
2. The Party will be responsible to provide transport (Bedford 6 wheelers, Mazda & Trucks) to 99 Talukas of 28 District including Jamshoro to Karachi as & when required by the Board through telephone for shifting of Textbooks to different Taluka Head Quarters of all the Districts. In case of failure in providing Transport in time a penalty of Rs: 20,000/- (Rupees: Twenty Thousand) only per day will be imposed and deducted from the bill of the party. The authority can withdraw / cancel the contract without notice / intimation.
3. The Party will be responsible for safe delivery of books at destination. In case of any loss / damage is occurred during shifting of Books, the party shall be responsible and the Board reserves the right for recovery of losses / damage from bill / security and the decision will not be challengeable in any court of law.

5. The payment of the services rendered will be made through cross cheque on submission of bill / builtly alongwith original receipt of the recipient and satisfactory completion of the job, certified by the officer concerned.
6. The Income Tax shall be deducted from the bills as per Government rules prescribed from time to time.
7. The party will provide the transport as and when required by the Board for shifting of Free Textbooks during the contract period. In case of failure to provide transport within required days, penalty @ of **Rs.20,000/-** per day/per truck will be imposed and deduction will be made from the bill of party. In case of complete/ full default, the entire amount of security shall be forfeited and the bidder / company will be black listed.
8. Any conditional, ambiguous or incomplete offer shall not be considered and will be rejected.
9. In case of any dispute arising between parties, the matter shall be referred to the Redressal Grievances Committee of the Board in accordance with Sindh PPRA Rules 2010.
10. The offers received from the parties will be evaluated on lowest cost basis as per rules.
11. The successful bidder will have to execute an agreement with the Board on stamp paper with 0.3% Value of the bid, borne by successful bidders after furnishing security deposit and before carrying out assignment as per Sindh PPRA rules 2010.
