11. The meeting of Central Purchase Committee (CPC) held on March 22, 2012 for the approval of vendors on the basis of specimen provided by following three qualified responsive bidders:
 - a. M/s SIMAB (Pvt) Ltd
 - b. M/s Habib & Sons
 - c. M/s Gujrat Steel (Pvt) Ltd
- 11.1 As per Tender Document Clause No. 3 under the heading of "Important Note", it was mandatory to all responsive bidders to furnish their Samples according to specs in order to verify the quality.
- 11.2. The committee appraised the samples and found that M/s Gujrat Steel (Pvt) Ltd had provided samples those were not conforming the specs as per tender documents. Although meticulous specs were incorporated in tender documents informing minute details but the company had provided samples of totally different dimensions & quality.
- 11.3. It was noted that M/s SIMAB (Pvt) Ltd., the other qualified responsive bidder, had also provided samples those were fully matched the specs of the tender documents and their quality was superior as compared to others competitors.

11.4. It was noted that the following were the lump sum cost offered by the responsive bidders to provide twenty two furniture items in respective quantities:

11.5. The committee decided that since M/s SIMAB (Pvt) Ltd., a most qualified responsive bidder, had provided samples of furniture items those were meticulously matches the specs and quality standards of tender documents therefore, approved to issue the Work Order in favor of the company at the total bid cost of Rs. 7,944,813.90 (Rupees Seven Million Nine Hundred Forty Four Thousand Eight Hundred Thirteen & Paisa Ninety Only.) inclusive to all taxes to avoid any further delay.

11.6. Subsequent to the meeting of CPC held on April 09, 2012 it was decided that Tablet Chairs, being the propriety item of a firm, be procured directly through single source manufacturer according to SPPRA rule 16 (b) (ii) i.e., under 'Direct Contracting'.

11.7. Hence the committee finally approved in its meeting held on April 09, 2012 to award the work on the overall responsive bidder i.e. M/s SIMAB (Pvt) Ltd., except the Tablet Chairs, at the cost of Rs. 3,971,813.90 (Three Million Nine Hundred Seventy One Thousand Eight Hundred Thirteen & Paisa Ninety Only) all inclusive.
