


- This contract agreement is made and entered into on $\frac{\partial 8/o5/2012}{\partial 8}$ BY AND BETWEEN. 1.
 - i) Inspector General of Police, Sindh having address Central Police Office, I.I. Chundrigar Road, Karachi, hereinafter referred as BUYER, which expression shall unless repugnant to the context or meaning thereof, be deemed to include its successors and permitted assigns officers delegated to perform functions procurements for an d on behalf of various units of Sindh Police department of ONE PART.

- ii) M/s. Atlas Honda Limited having its registered Karachi Plant at F-36 Estate Avenue, SITE Karachi (9221-2575561-5), hereinafter referred as SELLER, which expression shall, unless repugnant to the context of meaning thereof, be deemed to include its successors and permitted assigns of the OTHER PART.
- 2. WHEREAS the BUYER is entrusted with responsibility of procurement of motorcycles during current financial year 2017-2018 as per description and quantity, given below:-

AND WHEREAS, the BUYER, floated a tender vide No.3347/MT/VEH/2018 dated 26.03.2018 in accordance with Sindh Public Procurement Rules, 2010 (Amended 2017), as notified by t Government of Sindh vide notification No. SORI(SGA&CD)2-30/2010, dated 8th March 20 PURCHASER on the basis of clause 15(b) of SPP Rules (Amended 2017) i.e. National Com

That the SELLER submitted financial proposals on the bases of clause 15(b) of SPP Rules 2010 4. (Amended 2017).

5. That the rates offered by the SELLER for the motorcycles in accordance with clause 46(2) of SPP Rules 2010 (Amended 2017), were approved on the basis of Rule 48 of SPP Rules 2010 (Amended 2017). Therefore, on the recommendation of Purchase Committee as well as approval by the Competent Authority the BUYER agrees to place purchase order with SELLER on the terms & conditions, specified below:

6. NOW THEREFORE PARTIES HEREBY AGREED AS FOLLOWS


- That, SELLER shall supply complete 390 units of motorcycles described and specified at para 2 above, within 90 days after receipt of purchase order.
- ii) That, all deliveries shall be made to <u>MOTOR TRANSPORT WORSHOP SINDH</u>, <u>KARACHI</u> at address <u>POLICE HEADQUARTERS SOUTH</u>, <u>GARDEN KARACHI</u> between <u>0900</u> to <u>1600</u> hrs (on working days only) by the <u>SUPPLIER</u>.
- That, every motorcycles shall be made and finished in all respects to entire satisfaction of Departmental Inspection Committee of the **BUYER**, which shall be at liberty to reject any motorcycle or part thereof, if it is not in accordance with approved sample and specification mentioned in the tender documents submitted by **SELLER** at the time of bidding and evaluated and approved for this purchase order and such rejection shall be final. No appeal or review will be permissible against the decision of Departmental Inspection Committee.
- iv) That, the AIGP, MT SINDH, shall give written receipt signed by him giving out complete details, exhibiting the number of motorcycles DELIVERED, ACCEPTED and REJECTED. Such receipt shall be conclusive evidence of the acceptance and rejection of the number of motorcycles specified as ACCEPTED and REJECTED.

v) That, all motorcycles REJECTED shall be taken back and remped by the shall become due or recoverable by the SELLER in respect to ARRACHI

That, PAYMENT of all perforcycles ACCEPTED shall be made by AIGP, Eogistics, Sindh at below specified rate (F.O.R Destination Basis) within financial year 2017-18.

NOTE:

Advance payment against 100% Bank Guarantee (valid till **90** days after delivery) of value of supplies (to be completed as mentioned in clause 6(i) of the contract agreement for total 390 units) and the supplies shall be subject to approval by the Head of Department i.e. Secretary, Home Department Government of Sindh. In case of refusal by Home Department there shall be no liability on part of **BUYER**.

- vii) That, in case SELLER defaults in the due performance of this agreement/contract in part or full, AIGP, MT Sindh (Secretary, Purchase Committee) shall be at liberty to impose and recover LATE DELIVERY CHARGES @ 3% per month thereof. The penalty shall be applicable only the extent of motorcycles supplied late.
- viii) The AIGP, MT Sindh shall have right to assess, demand and recover any damages suffer the BUYER due to late supply of the motorcycles from the SELLER.
- The AIGP, MT Sindh shall be at liberty to deduct and retain the amount so assessed from the bill that may be or may become due and payable at or after the time of such failure of the SELLER, whether by virtue of agreement or otherwise.
- x) The **BUYER** shall not be responsible for non-performance of this agreement due to change in law, rules and policy of the Government as notified in official gazette from time to time.
- xi) That all conditions laid down in the rules framed for procurement by the Government shall apply to transactions made under this contract and both parties shall be bound by it.
- 7. This contract agreement shall be construed and the legal relations created herein will be determined in accordance with the laws of Islamic Republic of Pakistan.
- 8. Any notice required under this contract small be in writing and shall be effective when received by the addressee at its given address.

9. If any term, conditions, or provision in this agreement is found to be invalid, unlawful or unenforceable to any extent, the parties shall endeavor in good faith to agree to such amendments that will preserve, as far as possible, the intentions expressed in the agreement. If the parties fail to agree on such amendments, such invalid terms, condition or provision will be served from remaining terms, conditions and provisions, which will continue to be valid and enforceable to the fullest extent permitted by law.

10. This agreement may be amended only in writing signed by both the parties.
