 of the offered Godowns and will face/ bear liability coming up
 whatsoever with regard to these premises.
- That the Second Party will have to handover the vacant and sound possession of the Hired Godowns within Twenty Four hours after the execution of this Agreement.
- That the First Party will have to make arrangements of watch on the hired godowns after taking over the possession and the Second Party will have no intervention / interruption of any kind.
- That the private Godowns acquired under this agreement will remain under the use of storage of wheat by the First Party for the maximum period of (11) Eleven Months commencing from the date of agreement extendable with approval of the Competent Authority.
- The department reserves the right to vacate the premises at any time subject to clearance of the wheat stocks.
- That the first party will have no right to sublet the hired godowns or any portion of the premises.
- That the first party will have to clear the approve rent of Godown at Rs.<u>08/-</u> per Sq. Ft. per month after the receipt of the rent bill from the second party and subsequent receipts of funds from Government.

- 9. The rent will be payable from the date of taking over the possession and only for the period in which the space is utilized.
- All the admissible taxes (SRB, FBR, Withholding & Revenue Stamp Duty) etc; will be recovered from the bills of Second Party at the admissible rates at the time of payment.
- 11. That the Second Party will have the responsibility to make aeration adjustment and remove/ redress the shortcomings in the godowns structure (if any) noticed during the agreement period.

- 8. The Procuring Agency had requirement of 150000 Sq. Ft. of covered storage accommodation for safe storage of 30000 Metric Tons of Wheat Stocks of Crop 2018 but the offer has been received for total measurement of 81800 Sq. Ft. only by both the parties. The committee has discussed & review the estimated cost which were work down at the rate o Rs.9/- per Sq. Ft. & the copy of Annual Procurement Plan (APP) has been sent to the Sindh Public Procurement Regulatory Authority (SPPRA) through this office letter of even No.102 dated 25th June 2018 & which has been placed by the SPPRA on his website vide Sr. No.37790, SPPRA I.D. 2147483647 dated 27-06-2018. The matter was discussed among the members of the committee regarding the offered measurement, which was inadequate in comparison to the requirement of the procuring Committee. Thus, keeping in view the urgency of matter, it was decided to consider both the bids offered by the parties.
- 9. The comparative statement indicates not only the offered rates but also the rates approved previously. The result of increase or decrease has also shown in the comparative statement against both cases.
- 10. However, the members of the committee after discussion at length and physical inspection of SITE have recommended the rates offered by parties at Sr. No. 01 and 02 which indicated at Para 07 as acceptable.
