


**SUBJECT: TECHNICAL EVALUATION REPORT OF THE WORK

KARACHI**

- The above Tenders were called through press and also placed on the SPPRA Website (Copy enclosed) on the basis of two envelope and single stage method.
- Following was the schedule as per the advertisement:-
  - Tender purchase date on or before:- 10-03-2012
  - Pre-bid meeting date:- 17-03-2012
  - Technical Bid Opening date:- 22-03-2012
- Following four Firms purchased the Tender:-
  - 1) M/S Emfore Corporation.
  - 2) M/S Wadood Engineering Services.
  - 3) M/S Omega Engineering.
  - 4) M/S ZIAFCO Engineers & Contractors.
- The date of Technical bid opening was firstly extended to 29-03-2012 and then to 11-04-2012.
- The Technical Bids were finally opened on 11-04-2012 before the following Committee members:
  - 1) Dr. Shakeel A. Mallick – Additional Medical Superintendent (General), CHK
  - 2) Hayat Kamal – Project Director of the project
  - 3) Dr. A. Jabbar Memon – Deputy Director (Development) Health Department, Government of Sindh (Could not attend).
  - 4) Mr. Ziaul Hassan – Divisional Accounts Officer – A.G. Sindh Office
  - 5) Mr. Shahid Ali Khan – Accounts Officer – Civil Hospital Karachi
- Only one Firm i.e. M/S ZIAFCO Engineers & Contractors participated and their Technical Proposal was opened.
- Remaining three Firms did not appear and were absent.

- **The Technical proposal** submitted by M/S ZIAFCO Engineers & Contractors was examined in the light of basic requirement of origin for supply of Elevators i.e. USA, Japan, Western Europe or Equivalent.
- As M/S ZIAFCO Engineers & Contractors in their Technical Bid have offered Elevators of Korean Origin, so they are liable to be disqualified on this basis.
- **Conclusion**
- M/S ZIAFCO Engineers & Contractors are hereby disqualified and their Financial Proposal should be returned unopened.
