

Procurement of Poultry Medicine, Vaccine & Poultry Hospital Tools for office of the Deputy Director Poultry Production Karachi during the Year 2016-17.

Deputy Director Poultry Production Karachi informed the Forum that Tenders were called through Newspapers for Purchase of above item against the allocation of RS:36304000-00, provided under Regular Budgetary Provisions during the current Financial year 2016-2017. Tenders appeared in Daily "JANG" on 12-11-2016 & Daily "KAWISH" on 15-11-2016

& Daily "DAWN" on 12.11.2016. The tender was also placed on Government website on 09.11.2016. The Tender were sold 65 Firms out of 63 Firms responded, submitted sealed Tenders and provided the relevant / required documents i.e. Security deposit(CDR), NTN Certificate, Registration of Quoted items with Ministry of Health Government of Pakistan, Authorization Certificate, Professional Tax, Tax Returns, Bank statement, MRP list of quoted items, Affidavit, GST etc.

The Tenders were opened by the Procurement Committee on 09-12-2016 and same were scrutinized in its 2nd meeting held on 19-01-2017. Accordingly comparative statement prepared and placed before the Committee.

During the Scrutiny of Tenders / Comparative statement it is notices that mostly the items were quoted by the single Firms and there is no healthy competition except few items in which two or three firms quoted the rates. The Deputy Director Poultry Production Karachi briefed the Forum that the items are very essential and are required in the field on daily basis and also during the drought, rain / flood emergency period, it is fear that if the tenders re-advertised, it will be difficult to face the situation, and he requested for approval of purchase.

After detailed discussion on list of rates for the single quoted items and justification provided by the Deputy Director Poultry Production Karachi the Procurement Committee decided that:

. Items for which three or more than three, two or only one firms quoted the rates, as per SPPRA rule 48 acceptance of bid, the Procurement Committee approved the rates after observing quality and durability of the items and instructed that the rates quoted by the single participating firms should not higher than the market rates.

The Deputy Director Poultry Production Karachi informed the Committee that the GST issue raised by the Accountant General Sindh Karachi that the all items i.e. Medicines, Vaccines under the Head of "Cost Of Other Stores" will deducted through Bills at the rate of 17%. It will be difficult to face the situation, and the requested for issuance the letter for exempt GST.








