MD, WASA informed that the received Technical bids will be opened after one hour i.e. 2:00 P.M in accordance with SPPRA rule 67 of 2010 on page-73.

As per Technical Evaluation Criteria on least cost selection method, only one bid from M/s Sprint Express (Pvt) Ltd, Karachi was received till closing time of 2:00 P.M. for:

1. Conduct GIS based Survey of New Consumers and detection / unearthing of illegal connection and commissioning these for regularization.
