4. EVALUATION OF LOWEST BIDS.

(i) Detail evaluation of the bids was carried out in accordance with the terms and condition, specifications as per Tender Documents of this Secretariat and the SPPRA Rule-2010 (Amended 2013). The Procurement Committee finally determined the bid of M/S. H.U. Engineering Services, Karachi as the lowest evaluated bid for the Furniture & Fixture items as mentioned above at Sr.Nos.1, 2, 3, 4, 5,7,8,9,10,11,12,13,15,16,18,19,20, 24,27 & 28 and recommended to approve the 1st lowest bids of M/S. H.U. Engineering Services, Karachi for the said items.

(ii) As per Rule 37(1) of SPPRA Rule-2010 (Amended-2013), 5% of the bid price was fixed as bid Security in the Tender Documents of this Secretariat which was complied by M/S. H.U. Engineering Services, Karachi. But M/S. Sultan Enterprises, Karachi have submitted less than fix rate of bid security as mentioned in Tender Document (i.e. 5% Security bid). In the light of Clauses 15.1 & 15.4 of Instructions



The Procurement Committee therefore:






