- 2) Out of 8 Nos: only 2 Nos: Bidders M/s Pollution Engg: and M/s Pak Oasis submitted their bids within closing date, time and venue.
- 3) The Technical bidding proposals/ documents of both firms were opened on 06-03-2012 in presence of members of Evaluation Committee and representative of both firms.
- 4) The Technical Evaluation of Technical bids/ proposals of both companies were evaluated by the respective members of Technical/ Financial committee for STP Nawabshah, where M/s Pollution Engg: failed to get qualifying marks therefore Financial Proposal was returned un opened to the representative of bidders at the same date (26-03-2012) time and venue under SPPRA Rules, rule-46.
