The Convener of Committee has informed to all members of the Procurement Committee that Board allocated an amount of Rs.2.00 under the Head of A/cs " Purchase of other Misc:" in the budget grant for the year 2017-18.

Accordingly, after getting necessary approval from the competent authority invite open tender and published tender notice in leading newspapers as well as hoisted on the Official Website of SPPRA.

In response, Three (03) firms / bidders purchased the tender documents, out of which two (02) tender documents were submitted by the interested bidders on tender opening date. Tender was opened by the Tender Opening Committee on scheduled date & time i.e. 23.01.2018 at 1:00 p.m, in presence of the representatives of competing firms. Following bidders participated in bid and submitted their tenders:

1. M/s. Aamir Traders, Karachi.
2. M/s. Harmain Enterprises, Karachi.

On detailed scrutiny of received bidding documents of the Procurement Committee in the light of term and conditions as mentioned in the bidding documents and found that both participated firms have furnished requisite documents along with tender documents. Board kept a 100 Nos. marks for evaluation & qualification criteria i-e information of participated firms in term of experience, financial position and other necessary information. However, both firms obtained 80% marks out of 100% which is necessary to qualify.

A comparative statement of the unit prices as quoted by the bidders have been prepared by the Committee and observed that some discrepancies between unit prices and

total amount in BOQs as filled by the M/s. Aamir Traders and which exceeds by Rs.110,406/- between quoted amount and comparative amount. Comparative statement is annexed with the minutes at Flag "A". The detail summarized position of quoted prices by the participated firms as per comparative statement is re-produced below:-






