Notification of Procurement and Technical Standardization Committee was issued in 2012. The procurement procedure adopted this year was in pursuance to the old practice and done on the basis of the said Notification in good faith. However a new notification, meeting the requirement of SPPRA rule-7 and 8 has been issued. (Copy enclosed).

The department is currently under a great pressure to meet the challenges of outbreak of sheep pox, FMD, PPR, in the Livestock population of Tharparkar and adjoining districts which have claimed thousands of animal lives, resulting into loss of millions of rupees of subsistence farmers. The issue is being highlighted in the media and noticed by the Chief Minister. The district has been declared calamity hit area and the department is under directions from the Chief Minister Sindh & higher authorities to take all available preventive / curative measures to fight this outbreak. Special teams i.e. 15-20 numbers have been closed from all over the province to protect the animal population in the districts where outbreak of disease is causing maximum damage. The available resources of the districts have been provided to these teams.

There is an immense demand of vaccination & the medicines which have to be met from the purchase of Directorates, therefore in emergency, we may be allowed to complete all the procurements as per previous practice to save the endangered animal population of these calamity hit areas. It is further highlighted that if the procedure of procurement is adopted a fresh in the light of new technical and procurement committee it will be a great impediment in the drive of department which carried out in these areas, that may result in more damage and further loss of animals lives and finances. which may become un-controllable and damage the political reputation of the present government.

Rule-7 of SPP Rules, 2010 stipulated that the procuring agency shall, with approval of its Head of the Department, constitute as many procuring committees, as it deems fit, each comprising odd number of persons and headed by a gazetted officer not below the rank of BS-18, or if not available, the officer of the highest grade, and shall ensure that at least one third of the members of a procurement committee are from the agencies or departments other than the procuring agency. In the instant case no any outside members is included in the procurement committee and also it consists upon even number of members, which is not in sync with above provision of SPP Rules, 2010	Requested that exemption be given during this financial year in special case, because delay in procurement is hampering diagnostic facilities of livestock diseases in the province. We are already not capable to continue diagnostic activities in district Tharparkar, where thousands of small ruminants have been perished, this issue is spreading in other neighboring districts too; this situation comes under major natural calamity and special permission can also be given for the procurement of diagnostic material and first aid medicines/vaccines. Further more the existing experimental animals will also die due to non availability of feed.

Further submitted that no procurement has been made so far, hence no breach of Rule 32 (A) of SPPRA (2010) occurred. However, very little time has been left for the validity offer for the items under this tender and further delay is not in the interest of livestock farmers of this province.

It is therefore requested that either SPPRA may kindly be approached for hoisting this bid evaluation report on its website at an earliest possible or previous Purchase Committee be abolished and new committee be formed or keeping in view the major disease out breaks under natural calamity rules special permission be accorded.

iii	Comparative statement is not in original and its each page has not been signed by the procurement committee. Furnish original copy of comparative statement duly signed each page by the procurement committee.	The original copy of comparative statement signed by the committee and authenticated on each page by the concerned Director and Section Officer is hereby enclosed.
