



the Prime Minister.


The reason for both decisions by the filmmakers is intended to display the power dynamics at play as well, which make it difficult for victims of get justice.

# SHERPAO URGES **PAK-AFGHAN LEADERS** TO TALK ON ISSUES

MUQADDAM KHAN SWARI

Qaumi Watan Party Chairman Aftab Ahmad Khan Sherpao said that stability of Pakistan and Afghanistan was linked with each other, adding that the best option for leaders of the two nations was to set across the table.

He was addressing a gathering in Topi, Swabi, wherein Fida Muhammad announced quitting Pakistan Tehreek-e-Insaf (PTI) along with his supporters and joining the QWP, on Wednesday.

Sherpao said that increasing incidents of terrorism had put stability of people in the region at stake which, he added, was a big cause of concern for both the people of Pakistan and Afghanistan.

'No doubt, stability and prosperity of the two counties are interlinked. Instead of criticising each other, the leaders should hold parleys and find out a solution acceptable to them," he said. He said that the growing trend of extremism in the South Asian region was detrimental to progress and stability in the region, adding that the two neighbouring states needed to extend cooperation and improve their relations which would help in eradication of terrorism.

The issue of terrorism could only be addressed with mutual cooperation and respect and purposeful coordination to restore peace and stability, helping the two countries to achieve the dream of a true economic progress.

He rejected PTI's Chairman Imran Khan's demand for early elections. He said that in such scenario, Khyber-Pakhtunkhwa would be deprived of its five seats in the National Assembly to be increased in accordance with the fresh census.

"We want that the election should be held in time and those who just talk about change should let the Election Commission of Pakistan do its work according to the Constitution," he said.

About the general elections in 2018, he said that people were the best judges who knew everything and were well aware of the performance of the ruling parties.

"The voters had voted to power the religious parties but later rejected them in 2008. Similarly, the Awami National Party was also voted to power and rejected in 2013. I think it is PTI's turn because it failed to deliver and made only hollow pledges with the people," he said.

He claimed that the future belonged to the QWP and its leadership had worked day and night for the people welfare.

Myanmar leader Aung San Suu Kyi faced rising global pressure Tuesday to solve the crisis for her nation's displaced Rohingya Muslim minority, in a meeting with the UN chief and America's top diplomat in the Philippines.

UN Secretary General Antonio Guterres told the Nobel laureate that hundreds of thousands of displaced Muslims who had fled to Bangladesh should be allowed to return to their homes in Myanmar.

"The Secretary-General highlighted that strengthened efforts to ensure humanitarian access, safe, dignified, voluntary and

sustained returns, as well a true reconciliation betwee communities, would be en sential," a UN statemen said, summarising com ments to Suu Kvi.

Guterres' comments cam hours before Suu Kyi sa down with US Secretary o State Rex Tillerson on the sidelines of the East Asia Summit in Manila.

Washington has been cau tious in its statements or the situation in Rakhine and has avoided outright criticism of Suu Kyi.

# Saudi king hosts Lebanese patriarch in historic first

Visit comes at a time when Riyadh is stepping up pressure on Iranbacked Hezbollah

Saudi Arabia's King Salman on Tuesday hosted the head of the Lebanese Maronite church, a historic first at a time when Riyadh is stepping up the pressure on Iranbacked Hezbollah.

Beshara Rai arrived in Riyadh Monday, in the first trip to the kingdom by a senior Lebanese official since a crisis sparked by the shock resignation of prime minister Saad Hariri, which was announced from the Saudi

The patriarch and the king reviewed fraternal relations between the kingdom and Lebanon and confirmed the importance of the role of different religions and cultures in promoting tolerance, renouncing violence, extremism and terrorism", the state-run Saudi Press Agency

Rai is also set to meet Crown Prince Mohammed bin Salman on a trip that symbolises a rare inter-religious exchange in the ultra-conservative kingdom, which is

home to the holiest sites in Islam.

The Maronite patriarch's visit "stresses the kingdom's approach for peaceful coexistence, closeness and openness for all sections of Arabic people", Saudi Gulf affairs minister Thamer al-Sabhan said on Twitter.

Rai also met Hariri, who stepped down during a televised address on November 4 from Riyadh, in which he blasted Iran and its Shiite ally Hezbollah -- a member of the Lebanese government -- for intervening militarily in Syria and Yemen.

Lebanese senior politicians allege Hariri is under de factor house arrest, though he vowed in an interview on Sunday to return to Lebanon in "two or three days".

Hariri's resignation came against the backdrop of mounting tensions between Sunni Saudi Arabia and Shiite Iran, which back opposing sides in power struggles in hotspots such as Syria and Yemen.

French Foreign Minister Jean-Yves Le Drian has said France was "worried by the situation in Lebanon" and wanted to see the government there "stabilise as quickly as possible".

He is set to visit Riyadh on Thursday, AFP
