(**Annexure-A**) The report of Technical Sub Committee was placed before the forum and also read before the members and representatives of the firms/bidders.

As per report of the Technical Sub Committee all the bidders have furnished NTN certificate, sales tax registration, professional tax and earnest money. M/s Pakistan Trading House & M/s Mohsin Enterprises have produced ISO certification but M/s Shaheer Traders has not enclosed the same.

All three participated firms obtained marks as under:

1. M/s Pakistan Trading House 95/100
2. M/s Mohsin Enterprises 40/100
3. M/s Shaheer Traders 25/100

The Technical Sub Committee after scrutinizing all the relevant documents and criteria laid down in bidding documents recommended Pakistan Trading House who obtained 95 marks technically qualified for further participation in bidding process, whereby M/s Mohsin Enterprises and M/s Shaheer Traders who obtained 40 marks and 25 marks respectively stood disqualified as they both failed to obtain at least 70 marks for technical qualification does not confirm to the specified requirements and participation in further bidding process.

It was unanimously decided by the committee that only envelope marked as the financial proposal of M/s Pakistan Trading House, the only bidder who qualified in Technical process may be opened in presence of all the committee members and sealed financial proposals submitted by M/s Mohsin Enterprises and M/s Shaheer Traders found technically non-responsive may be returned unopened to the respective bidders but both representatives refused to receive their sealed financial envelopes.

Accordingly, the envelope marked as financial proposal submitted by M/s Pakistan Trading House was opened and signed by all the members of the Procurement Committee. The rates quoted for printing & supply of Tax Token Stickers were also read before the committee and are mentioned below:

In pursuance of notification No. SO(B&A)E&T/7(55)/2015(PC)/2852 dated 14-11-2016 and in continuation of Notification No. SO(B&A)E&T/7(55)/2015(PC)/3041 dated 14-12-2016 issued from Administrative Department as a committee was constituted for Procurement of Registration Number Plates for 2/3 wheelers & 4 wheelers / Uniforms liveries and protective clothing/ Tax Token stickers for Excise, Taxation & Narcotics Control Department Government of Sindh.

In this connection a meeting was held on 04-01-2017 for Procurement Tax Token Stickers in the office of the Director (Admn/MVR), Excise, and Taxation & Narcotics Control Karachi being the chairman of the Procurement Committee attended by all the members i.e

1. Mr. Waheed Shaikh Deputy Director (Admn), M R Wing Karachi.
2. Syed Ghulam Nab Shah Deputy Director (H.Q), Directorate General ET&NC.
3. Mr. Musarrat Mokhtar Deputy Director, Industries Department.
4. Mr. Ghulam Hussain Abbasi Section Officer, Transport Department.
5. Mr. Suhail Anjum Jaferi Section Officer, Home Department.
6. Mr. Muhammad Aslam Khan Section Officer, Labour Department.

Bids were opened in presence of all the member and the representatives of participating firms in which three (3) firms / bidders participated in the opening of tender which are as under:

M/s Pakistan Trading House
M/s Mohsin Enterprises
M/s Shaheer Traders

Further a Technical committee was constituted vide No. DVR/MR(43)/procurement/2016-17/2360 dated 21-12-2016 by the Director (Admn/MVR)/Chairman of the Procurement Committee to evaluate the bids of Number Plates (4 wheelers & 2/3 wheelers) and tax Token Stickers as per evaluation criteria and other details of bidding

documents and submission of report with specific recommendations to the Procurement Committee within 7 days from the date of opening of the bids.

In this regard a meeting was called by the Deputy Director (H.Q)/ Chairman Technical Committee vide 1(196)/2016/DG-TAX/144 dated 10-01-2017 held on 11-01-2017 at 04:00 pm in the office of the Deputy director (H.,Q) Directorate General Excise, Taxation & Narcotics control Sindh Karachi for evaluation of bids which was attended by Mr. Waheed Shaikh Deputy Director (Admn) Motor Registration wing Karachi and Mr. Musarrat Mokhtar Deputy Director Industries Department (Attendance Sheet enclosed at **Annexure-A**).

The envelopes containing the Technical proposals of all three participating firms i.e M/s Pakistan Trading House, M/s Mohsin Enterprises and M/s Shaheer Traders along with samples of Tax Token stickers received from the Chairman Procurement Committee vide No.DVR/MR943)/Tax Token/2016-17/040 dated 06-01-2017 which were opened and perused in detailed for evaluation purpose.

Following the parameters for the evaluation criteria for bids described in the Tender Documents, the Technical Proposals were scrutinized in detail by all the members of Technical Committee and every member individually awarded the marks obtained by each bidder (enclosed as **Annexure-B**). Whereby M/S Pakistan Trading House obtained 95 marks, M/s Mohsin Enterprises obtained 40 marks and M/s Shaheer Traders obtained 25 marks.

As discussed in the meeting of the Technical Committee Syed Ghulam Nabi Shah Deputy Director (H.Q) alongwith representative of the Industries Department visited the premises of M/s Mohsin Enterprises and M/s Shaheer Traders on the addresses mentioned in the bidding documents as both the firms did not submit any proof of tenancy / ownership of the premises, M/s Mohsin enterprises described in the bidding document has one office having address Shop No. 3, Iqbal market, Soldier bazar Karachi, which was visited but there was no manufacturing plant / unit, and M/s Shaheer Traders address mentioned in the bidding document was also visited but there was no any manufacturing unit found.

It is further mentioned as discussed in the meeting of Technical Committee that Mr. Waheed Shaikh member of the Technical Committee visited all three premises of M/s Pakistan Trading House for which the firm has submitted the valid tenancy agreements. As the manufacturing Plant / Printing Press was also available on the given address i.e. Flat No. 9, 2nd floor, Allah Bakht Afandi Manzil opp. Botal Gali Shahra e Liaqat Karachi.

Moreover regarding the mandatory requirements all three bidders have furnished N.T.N Certificates, sales Tax Registration, Professional tax Documents issued by the concerned Authorities. M/s Pakistan Trading House and M/s Mohsin Enterprises has produced ISO document but M/s Shaheer Traders has not produced the required ISO certification.

M/S Pakistan Trading House has produced the supply / work orders as a proof to have entertained similar projects whereas M/s Mohsin enterprises and M/s Shaheer Traders did not furnished work orders of relevant projects.


Further it is to mention here that M/s Pakistan Trading House has produced bank statement showing the turnover of last 4 years but M/s Mohsin Enterprises and M/s Shaheer Traders have only produced bank certificates without bank statement.

Moreover samples produced by all three firms / bidders are as per specification / requirement of bidding documents.


Recommendations

As the Technical committee scrutinized all the documents produced by the participating firms as provided in bid document for technically qualification, M/s Pakistan Trading House obtained the marks i.e **95 marks**, M/s Mohsin Enterprises obtained **40 marks** and M/s Shaheer Traders obtained **25 marks**. Hence M/s Pakistan Trading House is qualified for further participation in bidding process.

The meeting ended with the vote of thanks to and from the chair.


