

The Officer–In-Charge Livestock Experiment Station Karachi (Member) informed the Forum that tenders were called through Newspapers for purchase of above items against the allocation of 9.6 Million, provided under the regular Budgetary Provisions during the current financial year 2017-18. The Tenders appeared in Daily "Sobh" dated 03-10-2017, The "Express Tribune" dated 04-10-2017 ,Daily "Jang" dated 04-10-2017 & Daily "Mehran" dated 05-10-2017 and SPPRA web site on 04-10-2017, with the closing date 25-10-2017. Tenders were purchased by **09 Nos.** firms and submitted sealed tenders. The tenders were opened by Procurement Committee in its 1<sup>st</sup> meeting held on dated 02-11-2017 and representatives of **09 Nos.** firms were present at the time of opening of tender. During the 2<sup>nd</sup> meeting of Procurement Committee was held on 16-11-2017 the tenders were evaluated/scrutinized the tender documents, earnest money, income tax, general sales tax. It was decided that short falls of the call deposit and other documentations be collected from the firms before the 3<sup>rd</sup>/ final meeting but one firm M/S Choice Enterprises disqualified due to the not provide short fall of the call deposit amounting to Rs.151716/= up to 21-11-2017.

Procurement Committee evaluated/scrutinized and finalized the tender. In the light of justification provided by the Officer In-charge, Livestock Experiment Station Karachi. The Procurement Committee decided that:

The Meeting started as per schedule, Director General Livestock Extension/ Research Sindh Chairman Procurement Committee welcomed the participants of meeting and opened the discussion on agenda item for:-

Procurement of Animal feed & seed for office of the Officer—In-Charge Livestock Experiment Station (LES) Karachi during the current financial year 2017-18.

The Officer–In-Charge Livestock Experiment Station Karachi (Member) informed the Forum that tenders were called through Newspapers for purchase of above items against the allocation of 9.6 Million, provided under the regular Budgetary Provisions during the current financial year 2017-18. The Tenders appeared in Daily "Sobh" dated 03-10-2017, The "Express Tribune" dated 04-10-2017 ,Daily "Jang" dated 04-10-2017 & Daily "Mehran" dated 05-10-2017 and SPPRA web site on 04-10-2017, with the closing date 25-10-2017. Tenders were purchased by <u>09 Nos.</u> firms and submitted sealed tenders. The tenders were opened by Procurement Committee in its 1<sup>st</sup> meeting held on dated 02-11-2017 and representatives of <u>09 Nos.</u> firms were present at the time of opening of tender. During the 2<sup>nd</sup> meeting of Procurement Committee was held on 16-11-2017 the tenders were evaluated/scrutinized the tender documents, earnest money, income tax, general sales tax.
