Tenders appeared in **Daily "NATION" dated 12.11.2016, Daily "JANG" Dated 12.11.2016 & Daily "KAWISH" 14.11.2016**, the Tender was also placed on Government website. Tenders were purchased by 30 firms out of which 29 firms responded and submitted the sealed tenders and provide the relevant / required documents like **GST, C.D.R., NTN Certificate, last Three Years Income Tax returns, Bank Statement turnover of at least last two years, Registration of Quoted items with Ministry of Health Government of Pakistan, Letter for nomination as sole distributor / authorized dealer, Affidavit/Agreement, Professional Tax and MRP list of quoted items Leaflets / brochures / catalogues of quoted products along with samples.**


The tenders were opened by the procurement committee on 29-11-2016 and same were scrutinized by the concerned committee in its 2<sup>nd</sup> meeting held on 06-01-2017. Accordingly comparative statement prepared and placed before the procurement committee.


During the scrutiny of tenders/ comparative statement, it is noticed that mostly the items were quoted by the single firm and there is no healthy competition except few items in which two, three, four and five firms quoted the rates. The Deputy Director Livestock/ Animal Husbandry Kamber Shahdadtot briefed the forum that the items are very essential and are required in the field on daily basis and also during the draught, rain/ flood emergency period, it is fear that if the the tender re-advertised, it will be difficult to face the situation and he requested for approval of purchase.

After detailed discussion on list of rates for the single quoted and justification provided by the Deputy Director Livestock/ Animal Husbandry Kamber Shahdadtot, the Procurement Committee decided that:

- Items for which five, four, three, two or only one firms(s) quoted the rates, as per SPPRA rule 48 acceptance of bid. The procurement committee approval the rates after observing quality and durability of the items and instructed that the rates quoted by the single participating firms should be surveyed and the same are not higher than the market rates detailed at A & B.






