





7 RECOMMENDATIONS

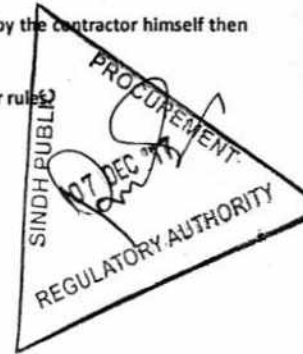
