FORM OF CONTRACT AGREEMENT

THIS CONTRACT AGREEMENT (hereinafter called the "Agreement") made on the 5th day of May 2016, between **Medical Superintendent, Civil Hospital Karachi** (hereinafter called the "Employer") of the one part and **M/s N & N Enterprises & Contractor, Flat # B - 6, Arif View, Sector 5 - K, North Karachi** (hereinafter called the "Contractor") of the other part.

- (b) The Work Order
- (c) The completed Form of Bid along with Schedules to Bid
- (d) Conditions of Contract & Contract Data
- (e) The priced Schedule of Prices
- (f) The Specifications

3. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy defects therein in conformity and in all respects within the provisions of the Contract.

4. The Employer hereby covenants to pay the Contractor, in consideration of the execution and completion of the Works as per provisions of the Contract, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.


