FORM OF CONTRACT AGREEMENT

THIS CONTRACT AGREEMENT (hereinafter called the "Agreement") made on the 6th day of May, 2016, between **Medical Superintendent, Civil Hospital Karachi** (hereinafter called the "Employer") of the one part and **M/s Shaheen Construction Company, 45 - C, 27th Street, Tauheed Commercial, Phase - V, DHA, Karachi** (hereinafter called the "Contractor") of the other part.

3. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy defects therein in conformity and in all respects within the provisions of the Contract.

4. The Employer hereby covenants to pay the Contractor, in consideration of the execution and completion of the Works as per provisions of the Contract, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
