

During evaluation/scrutiny of technical bids of following firms, it was found that they did not submit two envelopes of technical and financial bid in tender box, only one envelope found, which was against the tender specification\requirements (according to SPPRA Rules- 2010 under Rule No.46 (2) and vide clause No.1 of tender terms & conditions).
