### General Rules and Directions for the Guidance of Contractors

1. All work proposed to be executed in the form of invitation to tender posted on a Executive Engineer and signed by the Executive Engineer.

This form will state the work to be submitted and opening tenders, and the work; also the amount of earnest money to be submitted, the amount of the security deposit to be submitted, and the percentage, if any to be deducted there a refund of quarry fees, royalties, or granted. Copies of the specifications, rates schedule rates and any other document work shall be signed by the Executive Engineer, and shall also be open for inspection by the Executive Engineer during office hours.

2. In the event of the tender being signed separately by each partner then any partner, it shall be signed on his behalf by an attorney authorizing him to do so.

3. Receipts for payments made by a firm, shall also be signed by all partners as described in their tender as be signed in the name of the firm by persons having authority to give effect.

4. Any person who submits a tender, stating at what percentage above or below the memorandum showing items of work tender take the work. Only one rate of such tender shall be framed. Tenders, which propose to take the said form of invitation to tender, the work, or which contain any other conditions, will be liable to rejection. No printed form of tender shall include a tender for more than one work. But if contractors wish to tender for two or more works they shall submit a separate tender for each. Tenders shall have the name and number of the work to which they refer written outside the envelope.

5. The Executive Engineer or his duly authorized Assistant shall open tenders in the presence of contractors who have submitted tenders or their representatives who may be present at the time, and he will enter the amounts of the several tenders in a comparative statement in a suitable form. In the identification, sign copies of the specifications and other documents mentioned in Rule 1. In the event of a tender being rejected the Divisional Officer shall authorize the Treasury Officer concerned to refund the amount of the earnest money for deposited to the contractor making the tender, on his giving a receipt for the return of the money.

6. The Officer competent to dispose of the tenders shall have right of rejecting all or any of the tenders.


