MINUTES OF PROCUREMENT COMMITTEE MEETING FOR REVISED BID EVALUATION

- 1. A meeting of the Procurement Committee for the above cited work, held on 24-01-2018 at 3:00 PM vide meeting notice No. KW&SB/DAO/2018/15 Dated: 23-01-2018 in the light of decision of Complaint Redressal Committee dated 22-01-2018 for Re-evaluation of bidding Documents regarding complaint of M/s. Meraj Limited, who approached to the Chairman, KW&SB with an application that the lowest bidder has never executed such type of work. On his application, Chairman, KW&SB ordered that "Please examine grievance of applicant on merit according to law and put up".
- 2. The MD, KW&SB directed to the DMD(T.S) for verification of the documents under SPP Rules. The DMD (T.S) referred the case to CRC. The Complaint Redressal Committee nullify the last decision of Procurement Committee, in which M/s. Gujrat Steel Pvt Ltd. was declared as responsive bidder. The Complaint Redressal Committee advised for re-evaluation of the bidding Documents to select the eligible Contractor.
- During Re-evaluation of the bidding documents, it is noted that M/s Gujrat Steel (Pvt) Ltd is not fulfilling the eligibility Criteria as specified in the bidding documents. As per eligibility Criteria IB 13.4 (a)-i of bidding Documents " The bidder has completed at least one contract with minimum value of Rs.250 Million during the last 10 years". After re-scrutiny of the documents submitted by the bidders, it is observed that M/s. Gujrat Steel Pvt Ltd. has not carried out any single work of Rs.250 Million or above during the last Ten years as required in eligibility Criteria. Accordingly, the lowest bidder fails to meet the eligibility criteria, therefore M/s. Gujrat Steel Pvt Ltd. declared as nonresponsive by the committee during revised bid evaluation and M/s Merai Ltd and M/s Metal Engg Works (Pvt) Ltd are declared as Responsive and Qualified Bidders

DECISION: - M/s. Meraj Ltd declared the lowest responsive bidder under Rule 7.9.1(b) of SPP Rules 2010 with amounting to Rs.522,000,000/= (Rupees Five Hundred Twenty Two Million) and recommended for approval / sanction from Competent Authority.

On his application, Chairman, KW&SB ordered that "Please examine grievance of applicant on merit according to law and put up". The meeting was attended by all / following members of the Complaint Redressal Committee (CRC). (Attendance sheet is enclosed).

- 2. The Government of Sindh under ADP#1523/2017-18 provided funds for the execution of the above subjected work. KW&SB invited sealed bids on National Competitive Bidding (NCB) under single stage one envelop bidding procedure as per SPPR-2010 and opened on 27.11.2017 by the Procurement Committee.
- 3. After opening of bid, all the bids were evaluated by the Procurement Committee on the basis of the document provided by the bidders. Three bidders were participated in the bid, all bids were declared as responsive in first Evaluation Report . M/s. Gujrat Steel (Pvt.) Limited quoted the lowest rates i.e. Rs.49,94,47,500/= which was 9.44% below from the estimate prepared by the concerned Engineer. The committee evaluated the rates and Evaluation Report sent to SPPRA vide letter No.KW&SB/CE/ E&M-W/2017/184 dated 29.12.2017 for hoisting on the website of SPPRA subject to the approval from the Competent Authority.

The case was submitted to the Competent Authority for approval. Meanwhile 2nd Bidder M/s. Meraj Limited has submitted appeal to the Chairman, KW&SB that the lowest bidder has never executed such type of work. The Chairman, KW&SB ordered that "please examine grievance of applicant on merit according to law and put up".

The Managing Director, KW&SB directed to DMD (Planning) to put up report after enquiry. In response of the directives of MD, KW&SB, DMD (Planning) submitted his enquiry report on separate Notesheet. The Managing Director, KW&SB has ordered on Notesheet that please verify the documents under SPPRA Rules and marked to DMD (TS) for onward transmission and referred the case to CRC which is reconstituted vide letter no KW&SB/HRD&A/D.P/120 dated 19-01-18.

- 6. After re-scrutiny of the document provided by the bidders, CRC observed that the decision of procurement committee to qualify the M/s Gujrat Steel (Pvt) is not in accordance with the qualification criteria specified in the bidding document. As per the eligibility criteria IB 13.4 (a) (i) of bidding document "The bidder has completed at least one contract with minimum value of Rs.250 Million during the last 10 years". However, the scrutiny of documents submitted by M/s Gujrat Steel (Pvt) shows that the contractor has not carried out any work of Rs.250 Million during the last 10 years. Accordingly, the contractor fails to meet the eligibility criteria. The CRC hereby recommend to nullify the decision of Procurement Committee and advise for re-evaluation of the bidding document to select the eligible contractor.
