A meeting was held under the chairman ship of the Director, BSP/ Controller, W&M, Agriculture, Supply & Prices Department, Sindh for opening of Technical and Financial Proposal on 24th & 26th January, 2018 respectively, for the procurement of furniture & fixture, Plant & Machinery and Computer Equipment under ADP Scheme 26 Bureau of Supply & Prices for H.Q. Karachi at Karachi. The meeting was also attended by the members of procurement committee and the representatives of the bidders.

- The sealed envelopes, marked as **“Technical Proposal”** were opened on 24th January, 2018 by the Procurement Committee in front of the representative of the bidder and the proposals were evaluated in accordance with the SPPRA rules.
- During the scrutiny of technical proposal, it has been observed by the Procurement Committee that, the M/s Jumman Memon & Sons has not provided the SRB & Bank Statement Certificate.
- Accordingly it was decided by the Procurement Committee that the Financial Proposal of M/s Jumman Memon & Sons will not be opened.
- The procurement committee decides that the **“Financial Proposal”** of the qualified bidders will be opened on its next meeting which was scheduled to be held on 26th January, 2018.
- Subsequently, a meeting of the procurement committee was held under the chairmanship of Director, BSP / Controller, W&M, in his office on 26th January, 2018 at 11:00 AM to open and discuss the Financial Proposal for Furniture & Fixture, Plant & Machinery and Computer Equipment.
- All the members of the procurement committee attended the meeting.
- The sealed envelopes marked as Financial Proposals were opened and evaluated.
- The quality of samples and proposed rate of furniture & fixture quoted by M/s Nazeer Enterprises are found better and lower in rate in comparison to M/s G. M Enterprises.
- After going through the contents of the Technical & Financial Evaluation Sheet, the committee agreed to award the contract to the best evaluated bid i.e., M/s Nazeer Enterprises for **Furniture & Fixture, Plant & Machinery (Air conditioner, Water Dispenser, Stabilizer, PABX Board, Sound System, Screen Curtain, Binding Machine and fax machine)** and **Computer Equipment**, M/s Multi Tech for **Plant & Machinery (Multimedia Projector)** and **Plant & Machinery (Photocopier)** as they fulfill all the required criteria.
- The Committee allowed 15% permissible adjustment as per SPPRA Rules in respect of **Plant & Machinery (Air conditioner, Water Dispenser, Stabilizer, PABX Board, Sound System, Screen Curtain, Binding Machine and fax machine)** and for **Computer Equipment** against the quoted prices of the bidders.
- All the committee members signed the documents.
- The meeting concludes with a vote of thanks to end from the chairs.




