After opening the sealed bids, Procurement Committee scrutinized their responsiveness in light of eligibility criteria as per instructions contained in Rule-46(1)(a) of SPPRA Rules, 2010.

The committee shall examine the bids as per the eligibility / qualification criteria given in the bidding documents, arithmetical checks and verified the documents and bid security submitted by the bidders and found both the above-mentioned bidders responsive (copy enclosed).

Subsequently, PC went through the financial proposal and read out aloud the bids quoted by the bidders. The chairman of the PC encircled the rates and all the members of PC signed each and every page of the financial proposal.

The PC found the rates offered by M/s. A-One Traders lowest, recommended to ward the contract to them, in case there is no other issue involved and contact can be awarded in cade of two bidders. The Section Officer (Gen) would give its recommendations on this before awarding contract ad approval of competent authority.
