- i. The tenders purchased by the bidders up to date: 05-12-2017 at 12:00 PM were opened before the procurement committee in presence of representatives of participants.
- ii. The method for bidding was single stage - one envelop.
- iii. The bids were opened on 05-12-2017 (at 3.00 PM) before the Procurement Committee.

4. The committee was informed that 45-Nos bidders have purchased the bidding documents for all the 03 works up to date: 05-12-2017 (12.00 P.M) and 06-Nos have submitted the bids on 05-12-2017 up to 2:00 PM in the office of the Executive Engineer, Provincial Buildings Division No.III, Karachi.






