

MINUTES OF MEETING OF PROCUREMENT COMMITTEE OF LIVESTOCK & FISHERIES DEPARTMENT HELD ON 27.01.2017 AT OFFICE OF THE DIRECTOR, SINDH POULTRY VACCINE CENTRE, KORANGI, KARACHI TO OPEN THE FINANCIAL BIDS OF TECHNICALLY SUCCESSFUL BIDDERS FOR PURCHASE OF VARIOUS ITEMS UNDER ADP SCHEME # 1212.


The meeting was started with recitation from Holy Quran at 01:00 PM. The Chairman Committee, Director, Sindh Poultry Vaccine Centre briefed that, the tender were invited through advertisement, appeared in national newspapers viz Daily Express Tribune dated: 04.12.2016, Daily Jang dated: 05.12.2016 and Daily Awami Awaz on dated: 06.12.2016, respectively. The tender was also placed on the websites of Government of Sindh and SPPRA for public view on dated: 06.12.2016 respectively and up till closing date i.e. 20.12.2016. The tender were opened in presence of interested bidders on 20.12.2016.

The Procurement Committee scrutinized the bids technically and decided to open the financial bids of only technically successful bidders. The financial bids were placed before the Procurement Committee for opening in presence of the interested bidders / their representatives. The one envelope, two bid system (separate technical and financial bid) was adopted. Unsuccessful bidders returned their financial bids unopened.
