

Meeting started with the recitation from Holy Quran. The Committee was informed that as per the SPPRA rules 4.3, procurement over One Hundred Thousand Rupees and up to the limit of One Million Rupees shall be advertised on the Authority's website as well as procuring agency's website. Accordingly to the above rules, the sealed bids/quotations were invited through hosted procuring agency's website and Authority website as on 08.11.2017 at serial No.35157.

In response to advertisement, two (2) interested firms purchased the tender documents and submitted their bids (Attendance Sheet annexed at "A") which are as follows:

- 1) M/s. Cox Engineering
- 2) M/s. Mehran Engineering

The bids were opened by the Procurement Committee on 28.11.2017 in presence of the representatives of Bidding Firms and the rate quoted by bidders was announced. Committee preliminary evaluated the bid technically with regard to availability of required documents; viz. NTN and Sales Tax Registration, business experience and dealing of firms in supply of similar stores, committee has satisfied after preliminary evaluation of the documents submitted by the bidder.


The Committee has informed that due to the nature of work with regard to repair of generator is entire different and not to be ascertained actual cost of repair work. So, therefore committee has suggested that on first stage both the generators of 100 KVA & 200 KVA may be unbolt and actual cost shall be estimated and then estimation be proposed to next meeting of procurement committee for finalization of award of contract.

In the light of above situation a committee has proposed that call the lowest bidder to unbolt the generators and provide the actual estimated expenditures which are to be incurred for the said purpose and the matter shall be placed before next meeting of the procurement committee for finalization of contract.


Decision:
