

The Chairman thanked to participating bidders and adjourned the meeting for tea break and to say goodbye to representatives of vendors.






Bids were invited through advertisement in daily newspapers from eligible bidders for procurement of Furniture & Fixture Items for Primary, Middle, Elementary, High & Higher Secondary Schools under District/Provincial ADP-2015-16 (School-wise grant under Revenue Component).

The tenders were invited under SPPRA Rule 46/II single stage - two envelopes procedures for ensuring transparency in the procurement.


1. The Tender was published in widely circulated Nation-wide leading daily newspapers through Director Advertisement Sindh Information & Archive Department Government of Sindh vide reference No. INF-KRY: No.1171/2016. Here are the details of newspapers:

- 2) 04 Bidders participated in tendering process and submitted their (Technical & Financial) proposals on 18th April 2016 at 2.30.PM and same were opened on same date at 3.00 PM (Extended time) in the Committee Room of Directorate of Schools Education (Primary) Larkana Region Larkana, whereas 01 bidder not participated. The Technical proposals were opened in the presence of Tender Evaluation Committee members and the representatives of bidding firms.
