#### Sub: APPEAL AGAINST CANCELLATION OF TENDER

Please refer to your letter No.S&CL-00728/2011 dated  $3^{rd}$  February, 2012 disputing our cancelling the Tender for supply of desktop computers.

The Redressal Committee heard you in person on February 09, 2012 and provided full opportunity to explain your point of view. During the meeting it transpired that cancellation of Tender was the result of unsatisfactory performance of computers earlier supplied by your firm. A number of complaints were received from various users at different branches of the Bank. Long response time for addressing complaints, in some of the cases and efficient after sale service, were the factors responsible leading to the decision for cancelling the tender.

Your contention that the tender was cancelled after partial supply of 40 computers was not found tenable on the ground that purchase order for such computers was placed with a different firm. The committee gave due weight to your argument that most of the complaint pertained to software issues which is not within your scope of services. BUT the Committee was informed by the relevant department that besides software, there were several genuine hardware related issues and your response time was also not up to the required standard.

Having gone through your further deliberations vide your letter dated 10<sup>th</sup> February, 2012, the Committee is inclined to reconsider your request for restoring the cancelled tender, continuing business relations with you, PROVIDED you assure us of supplying said, high-tech and efficient machines coupled with prompt and efficient after sale service and quick replacement of affected parts.

# Minutes of Meeting of the Redressal Committee to discuss the complaints Lodged by M/s Science and Computer Link

The Redressal Committee met on 09/02/12 and again on 16/02/12 to consider the situation and reach a decision.

After initial meeting of the members on Feb 09, 2012, the Director of Operation, M/s Science and Computer Link, Mr Tahir Rizvi was called to hear him in person.

Mr Tahir Rizvi stated in detail the reasons of malfunctioning of his supplied computers. He was very determined on his stand that most of the problems arose in the working of the computers due to non availability / mismatching of the required software specialy that of antivirus software which was not activated. He also mentioned that despite this problem not being their responsibility they co-operated with Bank's Staff and removed / repaired their issues. Mr Tahir Rizvi however agreed that the computers were not 100% free from hardware problems, which are normally present in all Brands and that their brand is no exception. But he emhaisized that whenever and wherever such problems were detected they accepted their responsibility and wholeheartedly repaired / replaced the parts.

The Committee asked Mr Tahir Rizvi to provide a list of the complaints / problems that were made by the Bank and solved by them, with their assurance that if they were given the second chance, they will perform better and delaying tactics will be avoided.

Mr Tahir Rizvi provided the required details on Feb 10, 2012 along with the copies of the complaints filed by the Bank.

Copy of this letter was forwarded to I.T. Division and their comments were sought.

The I.T. Division replied on Feb 16, 2012 wherein thay agreed about the absence of antivirus software, but held the view thatM/s Science and Computer Links were not very responsive about solving the problems.

The Redressal Committee met on the same day again and after due consideration agreed to give a second chance to the vendor by restoring the cancelled tender, after receiving their confirmed assurance to supply the said hightech and efficient Machines coupled with prompt after sale service and quick replacement of affected parts.
