Discussion: Sr. Executive Purchase briefed the committee about the tender proceedings of "Provide, Supply & Fabrication of Medical Furniture & Ancillary Items". Procurement Committee in its meeting held on February 16, 2017 has taken the decision to defer the case. The committee reviewed the letter submitted by M/s Inspire Trading Co. on February 21, 2017. Manager Purchase & Stores has submitted finding that he visited M/s Inspire Trading Co. who made him visit Lucky Star Market for samples. Photos of samples are attached.

Further the committee contacted Mr. Nouman, representative of M/s Inspire Trading on phone for clarification, and he confirmed that their quoted brand does not fulfill the prime spees mentioned in tender BoQ. The committee reviewed the situation and therefore, in view of quality parameters and nature of items related to clinical equipment, the committee found the bid of M/s Inspire Trading Co. not conforming with the required specification and thus declared the bid as non-responsive. The bid submitted by M/s K&B Enterprises was found as the lowest evaluated bid as per SBD Clause 6(xxii).

Decision: The committee approved to award the tender for "Provide, Supply & Fabrication of Furniture Items for IBA Clinic" to M/s K&B Enterprises being the lowest evaluated bidder at Rs. 929.167.20 inclusive of GST.

Action: Manager Purchase & Stores will implement the decision in accordance with the prescribed rules & regulations framed by IBA PP&P and SPPRA.
