


- The fertilizers should be purchased on the current rates declared by the manufacturers / importers through print media on the date of procurement.

- All the firms will be responsible to deliver the goods at their own expenses within thirty (30) days after issuance of the supply order, failing which their supply orders will be treated as cancelled and same will be issued to 2nd lowest bidder (subject to qualifying technical specifications).
