
The Regional Directorate of Food, Karachi / Procuring Agency invited bids from the interested parties for transportation of wheat from various Districts of interior Sindh to Karachi for the period with effect from 1-6-2013 to 28-02-2014, vide this office Tender Notice NO: A/C (F-I) Tender-2013-14/2013/225 dated 14-05-2013. The Tender notice was published in the Daily "Ummat" dated 15-05-2013, "Dawn" dated 16-05-2013 and "Kawish" dated 16-05-2013, also hoisting at Sindh Government website www.sindh.gov.pk. The tender was opened as per schedule date on 31-05-2013 at 2.00 p.m in the office of Deputy Director Food Karachi..

In all, 72 Tender Forms were issued by the Regional Directorate of Food Karachi on account of transportation of wheat to the various interested parties/bidders but 22 parties were appeared and participated the bids.

Accordingly the tenders were opened by the Committee Members in presence of the bidders/representatives.. As per comparative statement, prepared on spot duly signed by all the Members of the Committee (copy enclosed), the parties appeared as lowest bidders for transportation of wheat are shown as under in comparison with the rates of last two years for same Districts and work:-
